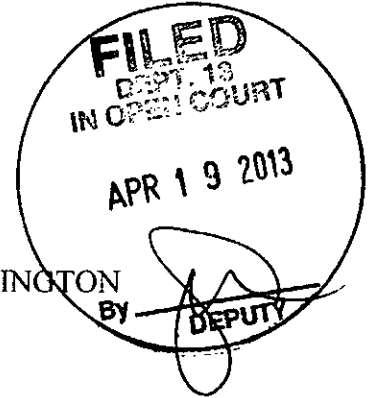

IT IS HEREBY ORDERED that Kitsap County Defendants' Motion for Reconsideration is GRANTED; and






